Dear Mr. Stroud,

I have submitted a letter dated October 8, 2019 related to this same issue and in light of the fact that this committee makes updates to its findings from public hearings I am submitting an update to that submission a year later with this letter.

I find myself fighting unlawful government activity almost on a 24/7/365 basis and never fighting random nut cases shooting somebody. This committee is about Mass Violence so let's get into that. Government Covid Restrictions across the nation have created a rise in unemployment from 6.2 million in February to 20.5 million in May. These government restrictions caused a rise in unemployment of 14.3 million. This is a rise from 3.8% unemployment to 13% in three months as reported by Pew Research.¹

It has been shown that a rise in unemployment of 1% causes from 37,000 to 47,500 deaths.² An increase in unemployment by 9.2% is the death of from 340,400 to 437,000 people mostly of the low skilled and income population. The total deaths in America from Covid as of this date is 218,000.³ That means that from 122,400 to 219,000 more deaths from government policy than from Covid-19. Never mind that 10% of the Covid deaths were from Covid only and not 2.5 other more serious health complications.

The state which has caused unemployment deaths to exceed that of Covid-19 wants to know how to stop occasional random shootings they call "mass violence." Can any shooting be compared to the mass violence imposed on the population by state orders to wear masks all the time, stay home for months, close your business, do business at 25, then 50 then 75 percent? This is called tyranny! We can argue forever about statistics concerning how many have died from Covid and unemployment.

1. But we can't argue about the following:

1.1. Long term Mask wearing is harmful to those who wear them as it causes hypoxia⁴ or oxygen deprivation and hypercapnia⁵ or concentration of carbon dioxide in the blood both of which can cause serious health problems including organ failure, heart attacks and death.

1.2. Staying home causes mental stress and anxiety knowing you cannot earn money at home instead of at work and cannot pay bills to live. This leads to

divorce, family violence, suicide, heart attack and stroke. An order to stay home is an order to destroy your family and kill yourself.⁶

1.3. Closing your business for any length of time can be detrimental and for months can cause a business to fail without income to pay its obligations. An order to do this is an order to destroy your business.⁷ 60% of businesses that have closed will not reopen.⁸

1.4. Anyone who has owned a business knows that operating at 25%, 50% and 75% of customer service will cost almost as much or more than normal operation due to overhead and waste. And who would doubt that any company will lose money instead of make money operating at reduced capacity. An order to reduce customer service is an order to destroy your business.

2. Are the above government decrees an act of mass violence? Yes indeed, and it is called tyranny as demonstrated below:

2.1. The state of Texas is set on The Foundation of the ancient natural self-evident law of delegated authority which says: "no one can delegate to another more authority than they hold in themselves" as so well stated by John Locke, upon whom all of American liberty is based according to Thomas Jefferson:

"Though the *Legislative*, whether placed in one or more, whether it be always in being, or only by intervals, tho' it be the *Supream* Power in every Commonwealth; yet, *First*, It is *not*, nor can possibly be absolutely *Arbitrary* over the Lives and Fortunes of the People. For it being but the joint power of every Member of the Society given up to that Person, or Assembly, which is Legislator, it can be no more than those persons had in a State of Nature before they enter'd into Society, and gave up to the Community. For no Body can transfer to another more power than he has in himself; and no Body has an absolute *Arbitrary* Power over himself, or over any other, to destroy his own life, or take away the Life or Property of another....Their Power (*Legislative*) in the utmost Bounds of it, is *limited to the publick good* of the Society. It is a Power, that hath no other end but the preservation, and therefore can never have a right to destroy, enslave, or designedly to impoverish the Subjects."⁹

2.2. This doctrine which limits the power of government to only that authority held in each individual in that society is The Foundation of the whole state of Texas in Article 1 Section 2:

"All political power is inherent in the people, and all free governments are founded on their authority, and instituted for their benefit. The faith of the

people of Texas stands pledged to the preservation of a republican form of government, and, subject to this limitation only, they have at all times the inalienable right to alter, reform or abolish their government in such manner as they may think expedient."¹⁰

- 2.3. We must ask the question: Do I have authority to wear a mask and stay home and close my business to protect myself from a virus? Yes!
 - 2.4. Then we must ask the question: Do I have authority to tell my neighbor to wear a mask, stay home, and close their business to protect me and them from a virus? No!
 - 2.5. If I, being equal to all my neighbors in authority as we are all equal in the eyes of God and our state, who has authority to tell his neighbor to wear a mask, stay at home and close their business? No one!
 - 2.6. Therefore we see clearly that the state of Texas and all its three branches of government cannot obtain the authority to tell all the citizens to wear a mask, stay at home and close their business.
 - 2.7. Some may say authority increases with a virus or emergency but the foundation of Texas is not built upon a show of emergency by experts or anyone else. Did Article 1 Section 2 mention anything about all power being based upon or increased with the showing of an emergency?
 - 2.8. We must ask the question: Did my authority increase upon the appearance of Covid-19? No!
 - 2.9. Therefore the authority of the state of Texas did not increase with the appearance of Covid-19.
 - 2.10. The exercise of power without authority is tyranny by definition, and living under same is the worst of human conditions filled with violence and destruction of society, culture, production and human life.
 - 2.11. The Texas Covid-19 Restrictions are tyrannical and give rise to the true purpose of the second amendment and the right of the people to alter, reform or abolish their government in such manner as they may think expedient.
3. We are living under Eventocracy where events give rise to power and arbitrary rule. The people have no say in how to respond and no way to limit the power of government as it is based, not on the authority of the people as intended, but rather upon the presumed and asserted authority of events, which does not exist. What is the nature and purpose of this Covid Event?
 - 3.1. There is no numerical threshold for the beginning or ending of a "pandemic," we are at the mercy of a group of men, who alone, will decree when the pandemic started and when it is over, if ever.
 - 3.2. There is no medical agreement as to the existence of Covid-19.
 - 3.3. There is no good test for Covid-19 as the PCR test returns 90% false positives.

- 3.4. The state of Texas has cheated in the counting of cases to make them exponentially higher than they can prove as shown by this document making the counting and reporting almost on an hourly basis an intolerable absurdity.¹¹
- 3.5. The whole purpose of the counting and reporting of fake cases of Covid-19 is to maintain the destructive restrictions upon the people of Texas so that the only way to remove this daily pain is to take a vaccine regimen and a digital tattoo or implant which the people would not do otherwise.
- 3.6. This is extortion and it is terrorism. It is the use of bodily harm and public destruction of property to alter public policy. It is state terrorism against its own citizens. And now the state wants to question the public about mass violence and how to stop it? The state is exercising mass violence and the only way the people may be able to defend their life, liberty and possessions is by the use of the 2nd Amendment and Article 1 Section 2 of the Texas Constitution to abolish the tyrannical dissolved state of Texas and make a new one which will protect their property.
- 3.7. Bankers have desired a cashless global society and this Covid Tattoo or implant will give them the technology to upload digital compliance currency to the implanted chip.¹² Those who comply will receive sufficient digital credit currency and those who do not comply will receive less and less until they comply or die.

This is the purpose for all the unnecessary Covid flu Restrictions to impose hardship upon the people until they see the only way out is submission to vaccines which are also harmful and a digital implant of some kind. This must be stopped and this committee needs to exercise their duty to stop mass violence as their duty to stop their own government from doing it to force their own people into demeaning destructive subjection. We presently live under a demonic eventocracy which must be stopped if society is to continue.

And most importantly God made the world filled with viruses and God made man in his own image to live in a world filled with viruses and in fact man is a walking sack of viruses and germs. All that protects man is community immunity.
