# Covid Tyranny

## **People & Individual:**

Many take Art 1 Sec 2 to mean the group of individuals, or “people,” authorize government and that government can have more power and authority than an individual. But that is impossible as the authority of an individual does not increase when he joins in a group. All any lawful government has is what each individual has to delegate to government. The group has nothing each individual does not have and groups and individuals cannot delegate any more than that to government.

The other mistake made is to think that the individuals or people authorize the creation of government and once authorized it can do anything that is made law by the three branches of government. That would mean the government can obtain more authority than each individual has and become all powerful as the State of Texas has done with the so-called “Covid-19 Pandemic.”

## **Your Rights:**

If you argue that you have rights to not wear a mask and not close your business and not take a vaccine, others will tell you that your rights are not absolute and that during an emergency those rights can be suspended. And of course the government is the one they say that has authority to suspend your rights during an emergency.

Those who want to restrict your rights will of course try to make you feel guilty for wanting to exercise your rights when that exercise supposedly hurts the lives of others by possibly infecting them with a virus you didn't know you had.

What you don't have is more important than what you have. *If you don't have it, government can't get it.* Therefore, the correct argument is the exact opposite.

## **Want of Authority:**

You don't have the right to tell your neighbors what to do in an emergency. So how does the government get the right to do that if you and I don't have it? They don't have it and they can't get it!

This argument puts a worse guilt on those who are trying to force others to do their will without authority to simply feel safer. Those who do that are both arrogant and ignorant.

## **Application of Authority:**

If someone is trying to prevent you from wearing a mask, getting a vaccine, or closing your business, the government has authority to help you exercise your right to do those things. But the government cannot help you make someone else wear a mask and take a vaccine or digital implant and close their business.

If someone is trying to force you to wear a mask or take a vaccine and digital implant, and close your business, the government has authority to stop that force being applied against your will.

## **Unlawful Lockdown:**

The government can help you do what you have a right to do but they cannot help you do what you don't have a right to do. The government has no authority to impose Covid-19 restrictions on anyone! Remember Article 1 Section 2 of the Texas Constitution did not say authority came from emergencies or pandemics but from the people. Nor did it say the authority of the people or the government increases with pandemics and emergencies.

## **Limited Government:**

Most folks will tell you that they are in favor of limited government but have no clue as to how that is achieved. They think it's a matter of democratic debate and voting. But in reality government is limited because the people are limited and cannot delegate what they do not have to government. Therefore the government can never be unlimited regardless of democratic debate and voting. Many issues decided by election the people have no authority to decide, with or without a majority.

## **Emergency is Irrelevant:**

We see now that it makes no difference whether or not the Covid-19 Pandemic is real. Nor does it matter how severe the pandemic becomes, because the government cannot obtain lawful authority to impose the past and present Covid-19 restrictions on anyone even if people were dying in the streets. Your authority did not increase with the appearance of Covid-19 and hence the authority of the government cannot increase.

## **Covid Tyranny:**

The exercise of power without authority is tyranny. We see how the government cannot obtain authority to order people to stay at home, close their business, get vaccines, get a digital implant, stay six feet away from all others, and don't meet in groups. Therefore these restrictions are tyrannous by definition.

# Covid Terrorism

Terrorism is the use of harm (real, threatened or pretended) to alter public policy or law. Mask wearing is harmful to those who wear them as it causes hypoxia or oxygen deprivation and hyper-

capnia or the concentration of too much carbon dioxide. Both conditions cause serious health risks including death. Masks should not be worn for long periods of time as permanent damage can result.

Staying at home causes stress, suicide, divorce, and family violence. Closing a business for months will be the end of the majority of businesses. Operating a business at various levels of reduced customer service will also drive many out of business.

All these measures constitute violence and harm to the people and it is used to make them submit to taking vaccines and digital implants which they would not do otherwise voluntarily.

Global bankers have dreamed of a cashless society for years and this will pave the way for its institution where those who comply to the will of bankers will have sufficient digital currency uploaded to their digital implant.
