

Declaration of Intent to Form a New Republic of Texas As Guaranteed by The Present U.S. Constitution and The Present Texas Constitution of 1876

Article 1 Section 2 of the present Texas Constitution of 1876 guarantees the inalienable right of the people of Texas at all times to alter, reform or abolish their government as they may think expedient as long as the new government is in the republican form as so described in said article where all political power of the government is limited at all times by the authority held in each individual member of that governed society:

"All political power is inherent in the people, and all free governments are founded on their authority, and instituted for their benefit. The faith of the people of Texas stands pledged to the preservation of a republican form of government, and, subject to this limitation only, they have at all times the inalienable right to alter, reform or abolish their government in such manner as they may think expedient."

Our right to abolish the present "state of Texas" and replace it with a New Republic of Texas as we think expedient is unalienable meaning it cannot be lawfully hindered or prevented by law or force of any kind as long as the New Republic of Texas is in the Republican Form. This article does not require that an abolition of the present "state of Texas" and creation of a New Republic of Texas be accomplished via the legislature of the present "state of Texas," but rather such pursuit by anyone or any group or groups is protected as long as the form being proposed and instituted, by each or all, is in the Republican Form as so stated herein.

Article 4 Section 4 of the United States Constitution guarantees every state in that union a Republican Form of Government and shall protect each of them from domestic violence. This would include violence against the people to prevent them from exercising their inalienable right to abolish their state and make a New Republic in the form so stated in Art 1 Sec 2 of the Texas Constitution of 1876.

"The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence."

The guarantee quoted above requires the union to protect the people from violence used against them to prevent them from abolishing their state and making a new one in the Republican Form upon application of the legislature or executive of the New Republic of Texas in the process of making it operational. To maintain compliance with its promise quoted above the "United States" must also rescind or repeal any law applicable to this New Republic of Texas that contradicts the Republican Form stated herein. All states, nations and governments in a form other than that expressed herein are tyrannical.

We now set forth proof that the present "state of Texas" is not in the Republican Form the people agreed to in 1876 and we pledge that our New Republic of Texas will purge these tyrannical practices from our land. However, Article 1 Section 2 of the Texas Constitution of 1876 does not require that we show or prove that the present state of Texas is not in the Republican form prior to the exercise of our inalienable right to abolish the state, at any time, as long as the New Republic of Texas is in the Republican Form described in said article. Even though proof of noncompliance with a Republican Form is not a prerequisite to abolition of the

present state of Texas, it certainly makes the present state of Texas indefensible by any party or authority. Only one provision of law making the operational form of Texas contradictory to the Republican Form is sufficient for the people to abandon the tyrannical state and establish a New Republic of Texas in conformity to the Republican Form of government:

1. All provisions, and they are numerous, of the Texas Constitution of 1876 that permit ad valorem property taxation are not in the Republican Form. No state may ever impose a property tax as that is alienation of the property not protection of same. No one has authority to alien your property as security for the performance of anything in the creation or support of government, and hence cannot delegate such an authority to the government to exercise.
2. "Absolute Sovereign Immunity" (Texas Tort Claims Act of 1969 and its codification in the Texas Civil Practice & Remedy Code Title 5) to harm the property of the citizen even unto death without judicial recourse unless waived by statute or congressional resolution prior to filing suit is contrary to the Republican Form of government. No one has authority to harm their neighbor much less without judicial recourse, hence, they cannot delegate such an authority to the state to be exercised. The sole purpose of the state is to protect the life, liberty and possessions of each individual from all others including the state.

We could list others but these are major tyrannical provisions that cannot conform to a Republican Form of government making the present state of Texas tyrannical and indefensible by any honest entity. Article 1 Section 2 of the Texas Constitution of 1876 is based upon the ancient natural law of *delegated authority* which says; "no one can delegate to another more authority than they hold in themselves." There is one other fundamental principle we would express and adhere to throughout the creation and operation of the New Republic of Texas; namely, that the sole purpose of lawful government is the protection of property consisting of the life, liberty and possessions of every individual in the governed society. Lawful government must adhere to these two principles of *singular protective purpose* and *limited delegated authority*. No individual's property may be harmed for the greater good of the state or the people thereof. The "greater good" is best served by adherence to those two principles.

We submit to the world one other very important reason for the creation of a New Republic of Texas. A Republican Form of government protects its citizens from the false doctrine of *eventocracy* that deceives the people into allowing tyrants to exercise more authority than they can obtain lawfully based upon the notion that authority comes from emergencies rather than individual citizens at all times. Authority of individuals does not increase or decrease during emergencies or events no matter how severe or threatening. Had we had a Republican Form of government as described herein we would have never been forced to stay home, wear a mask, get endless shots of experimental potions, close our businesses, open our businesses in stages, etc.

We ask all nations and states to establish lawful government in their lands and enjoy freedom from eventocracy and its tyrannical operations such as the "Covid-19 Pandemic" and its destructive and deadly mandates, "The 9/11 Terrorist Attack" and its "Patriot Act," and Mass Shootings used as an excuse for unlawful disarmament of the people. We also pray for Australia and all other nations and states that they are successful at ending destructive tyranny and obtaining lawful government!
