Dear Pastor \_\_\_\_\_,

As you know CNN and its owner, TIME WARNER, have stepped up their campaign to disarm the American people in the aftermath of the shootings at Sandy Hook Elementary in Newtown, Connecticut. CNN is using their powerful global 24-7-365 television network to misinform the people of America about the purpose of the Second Amendment and the right of the people to not only be armed with military style weapons but to be organized in well regulated and trained militias.

We all know guns, of any kind, are not responsible for the shootings at Sandy Hook or Columbine or the Aurora, Colorado Theater and banning them throughout America will not stop mentally ill people from harming others, but in fact such a ban, will lead to an American apocalypse. We also know that all the shooters in these tragedies were either on psychotropic drugs or were just coming off of them. But you do not see CNN and TIME WARNER attempting to ban psychotropic drugs which they advertise on their networks.

We also know that America has 154 million in the workforce and anywhere from 11 to 15 million of them are out of work. **"Rex 84**, short for **Readiness Exercise 1984**, was a secretive "scenario and drill" developed by the United States federal government to suspend the United States Constitution, declare martial law, place military commanders in charge of state and local governments, and detain large numbers of American citizens who are deemed to be "national security threats", in the event that the President declares a "State of National Emergency". The plan states events causing such a declaration would be widespread U.S. opposition to a U.S. military invasion abroad, such as if the United States were to directly invade Central America. To combat what the government perceived as "subversive activities", the plan also authorized the military to direct ordered movements of civilian populations at state and regional levels."<sup>1</sup>

It is a known fact that paper money is unconstitutional in America under Article 1 Section 10 of the US Constitution and there is no amendment to authorize it, yet it was imposed upon by unlawful

legislation. Any time a law is passed that alters the constitutional form of a government without the required amendment or approval of the people; it dissolves the government and removes all the authority from all the officials and employees of it. This unlawful paper money was backed, not by gold and silver, but by all the homes and property of the people according to the Congressional Record of 1933 as a result of the Emergency Banking Act. This will produce all kinds of social chaos wherein the dissolve federal government will be tempted to use military power over the population of America forcing them to relocate and work in FEMA camps.

Any true American knows that the purpose of the Second Amendment was not to solely hunt deer and keep one or two burglars out of your home as CNN, TIME WARNER, and all other globalists would have us believe. The true purpose of the Second Amendment was about stopping Federal tyranny as so stated by the Preamble to the Bill of Rights:

“**THE** Conventions of a number of the States, having at the time of their adopting the Constitution, expressed a desire, in order **to prevent misconstruction or abuse of its powers**, that further declaratory and restrictive clauses should be added: And as extending the ground of public confidence in the Government, will best ensure the beneficent ends of its institution.” (Bolding added)

And Alexander Hamilton in his Federalist Letter #29 told us that the militia should have all the weapons any standing military had and that they should be skilled at using these weapons:

“..it will be possible to have an excellent body of well-trained militia, ready to take the field whenever the defense of the State shall require it. This will not only lessen the call for military establishments, but if circumstances should at any time oblige the government to form an army of any magnitude **that army can never be formidable to the liberties of the people while there is a large body of citizens, little, if at all, inferior to them in discipline and the use of arms, who stand ready to defend their own rights and those of their fellow-citizens**. This appears to me the only substitute that can be devised for a standing army, and the best possible security against it, if it should exist.” (Bolding added)

A federal standing army cannot be funded by the federal government for more than 2 years after the conclusion of a lawfully declared war. The federal government has maintained an unlawful standing army for 65 years, further evidencing the dissolution of the federal government, and this standing army is now posing a threat to the American people.

Therefore, it should be obvious under the present circumstances that there is a lot more to this push to disarm the American people than CNN and the globalists are telling the people.
