I want this submission to be included in information received at your public hearing held at Brookhaven College in Farmers Branch, Texas this Thursday 10/10/2019.

There are two crimes committed at a mass shooting: the shooting of people, and the demand for disarmament of the American people. Both are crimes in America. It is against the law to kill and injure people with a gun or any other thing except in self defense. But it is also a crime to disarm the people. The second crime is of greater importance than random shooting events.

Also we know the US State Department has a program called "Freedom from War" wherein the government will confiscate all arms of the American people and give the federal heavy arms to the UN and retain only small arms to compel obedience of the American people. This is a tyrannical program on its face and demands that we consider the very strong motive to set-up, intercede, manage, and execute a series of mass shootings and cover-up details that would reveal covert involvement in order to get the people to demand "gun bans." Those who want to disarm the American people know they cannot do this directly with legislation without some driving force set in motion so the people themselves will think they need to be disarmed for safety. Why legislate disarmament when with a series of managed events the people will demand it and disarm themselves?

Who would tolerate a demand for murder? It is against the law! So why do we tolerate a demand for disarmament of the people? It is against a higher law! It is a more serious

crime to disarm the American people removing their only defense to tyranny than a few random shootings. Preservation of the 2nd Amendment and the God given right of self defense and group defense against tyranny is the most important law of the land. And the 2nd Amendment covers "military style" weapons because the military has them and the purpose of the 2nd Amendment is to prevent a military from violating the law and harming the people and their property. See the preamble to the federal bill of rights. Also see Federalist Letter #29.

Further, those who use the violence of another to demand alteration of the 2nd Amendment agree to use violence to alter the law of the land. This is correctly termed "conspiracy to commit disarmament terrorism." In a conspiracy to commit disarmament terrorism the actors need not know one another. The actors can come and go. Those who do, threaten, or pretend violence do not need to be the actors that demand the alteration of the law and visa versa. It is only necessary that a person agree to use violence (actual, threatened, or pretended) to alter the law of the land. And we are seeing a series of actions under a Conspiracy to Commit Disarmament Terrorism. If we prevent these terrorists from being able to achieve their goal by mass shootings the events will diminish and disappear.
